Title: An act to reform immigration and extradition policies in Sweden.

BE IT HEREBY ENACTED BY THE GENERAL ASSEMBLY OF THE UNITED NATIONS

Justification Clause: Sweden's welfare system is financially burdened by the high number of unemployed immigrants. Their cost of care is forcing our government to cut food services to our own elderly citizens. Sweden now has a higher poverty rate than the United States, a reduced middle class, and a soaring tax rate. Sexual assaults have increased 500%. 85% of convicted rapists are foreign born or of foreign parents. Rapes involving victims under age of 15 are six times more likely today than a generation ago.

Section I:Sweden will not accept political refugees or those seeking political asylum for a period of 24 months. Current immigrants on work/student visas must be registered and undergo a criminal background check. Failure to do so will cause immediate deportation back to country of origin.

Section II: Current immigrants have one year to find employment or become a full-time student with tuition paid personally or academic scholarship, not a hardship/financial aid government scholarship. Failure to do so will cause immediate deportation back to country of origin.

Section III: Any immigrant convicted of a sexual assault, felony, or hate crime will be immediately deported back to country of origin. This section will be enforced by The Executive Committees on Humanitarian Affairs and Peace and Security (ECHA/ECPS) United Nations (UN) and Nongovernmental Organization (NGO) Task Force on Protection from Sexual Exploitation and Abuse was established in February, 2005, with the aim of preventing acts of sexual exploitation and abuse and improving response to it when it occurs. Co-chaired by the Organization for the Coordination of Humanitarian Affairs (OCHA) and the Department for Field Support (DFS) and consisting of more than 30 UN and non-UN entities, this Task Force took up the work of the Inter-Agency Standing Committee (IASC) Task Force on Protection from Sexual Exploitation and Abuse. This is a plan already in existence in the United States.

Section IV: Only job-related, new immigrants will be allowed for a period of 24 months. These are described as aliens with "extraordinary ability," "outstanding professors or researchers," "multinational executives or managers," "professional with advanced degrees," skilled workers, and spouses/children under 18. Their entry is to relate to shortages of persons with such skills in Sweden.

Section V:Businesses who hire immigrant workers will receive a grant equivalent to \$5,000 US dollars for being part of a test program. Conflict resolution social workers trained will be available to assist in any human resource problems that may arise between Swedish workers and immigrant workers.

Section VI: This proposal will go into effect January 1, 2014.
