Title: An act to reduce the possible occurrence of a civil war in the country of Yemen, by establishing a new 3 step process, that will pacify the highest priority of problems that could potentially cause a civil war, further known as the YCPA (Yemen Civil-war Pacifying Act).

BE IT HEREBY ENACTED BY THE GENERAL ASSEMBLY OF THE UNITED NATIONS

Justification Clause: Currently Yemen is a country "just waiting to fall in a civil war" as stated by its own president. This is because of the vast and diverse problems this country is facing. It is expected that within the span of 10 years Yemen's government water supply is predicted to go fully out of stock. Seeing that 80 percent of the conflict in this country always relates to water is a troubling fact in its self. 75 percent of the Yemen government's income comes from its oil, but now it is expected that this oil will deplete soon or if not even faster than the current water crisis. If the most popular alternative to oil in most regions of the world (gas) is approached, it is predicted an influx of 1 billion dollars will be added to the government's expenses annually. With this government on the verge of a civil war, thought to be worse than those in Somalia and Afghanistan due to domestic violence and other issues, is putting it on the brink of an explosion of even more chaos than this country can withstand. This proposal will counteract and address all of these harmful things by establishing a 3 step process to neutralize and pacify a very likely civil war, and pacify it to an extent where it can be held under control.

Body of Proposal:

Section 1: This proposal will pacify a civil war, while possibly bringing some of this country's major problems to a halt, by establishing a new proposed 3 step process known as the YCPA (Yemen Civil-war Pacifying Act). By using the YCPA to address some of the 3 major problems, we can decrease those problems, and that resulting in stopping or delaying the numerous problems in this country as well as the evident civil war that is about to begin.

Section 2: When examining this country's 3 major problems, they are seen to be violence, lack of water, and lack of oil. All three of these things adding pressure for a civil war. The YCPA will consist of 3 parts that will address and neutralize these issues to the point of control and possibly preventing a civil war from occurring. These parts will consist of:

- (a) That a monthly representative from the UN (united nations) (having experience in the category(les) of country water and oil development) will be sent to meet and associate with members of Yemen's government that preside over Yemen's water and oil to give them an idea on how to monitor these thinas.
- (b) That on a monthly basis, due to availability, an amount UN troops that are within the borders of Yemen will be deployed and redirected to areas of the country that are predicted to have conflict within a 6th month period to ensure that the people of those areas are well informed of the situation and to provide security that may be needed.
- (c) That a group of representatives in the UNGA (United Nations General Assembly) will be elected to oversee this project (as an individual) in Yemen's Capitol building (two from Yemen, one from a developing country, and two from developed countries. It is the responsibility of Yemen officials to have a presentation ready for these representatives for each meeting, and to update them as frequent as possible about the countries condition.

Section 3: Specifications:

- -The monthly representative that is talked about in part (a) will be a member of the UN that oversees different projects and proposals that are put into effect, therefore causing no additional salary payments.
 - -The troops that are talked about in part (b) will be determined by their geographic location and availability.
 - -The election of the overseer talked about In part (c) will be dealt with in accordance to the UNGA.

Section 4: If it is found that the people who will carry out and lead this proposal are in non compliance with this bill in any way, will be dealt with in accordance the UNGA to make sure the punishments are fit for the offense. Each subsequent occurrence will be dealt with in the same way as the first offense.

- Section 5: This proposal will be ensured and enforced on behalf of the entirety of the UN, as well as a branch of the UN known as the UNGA.
- Section 6: There will be no cost or additional cost implemented upon passage of this proposal.
- Section 7: Upon approval, this act (proposal) will take place exactly 6 months after passage, allowing time for the UN to fully prepare for the implementation of this proposal.
