1 An act to Allow Casino Gambling in Kentucky

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

4
5 Section 1: The Commonwealth of Kentucky will authorize casino gambling for the purpose of partially funding
6 public schools, police and fire fighter training, and the Division of Kentucky Vehicle Enforcement. Each of the
7 aforementioned organizations shall receive 5% of the 30% Casino Tax. Any remaining taxes will be used for
8 road and bridge repairs.

10 Section 2: Applicants for a casino license must be twenty-one years old and free of felony convictions.
11 Applicants must pay a non-refundable license fee of \$25, 000.00. Casino sites cannot be within one-quarter
12 mile of schools, daycares, pre-schools, and any other facility that the primary users are children. Also,
13 hospitals will not be within a quarter mile of a casino.

15 Section 3: Casinos will be regulated by the Kentucky Horse Racing Commission. The commission will be
16 renamed the Kentucky Horse Racing and Casino Gambling Commission. The profits of casinos will be taxed at
17 a rate of 30%. This percentage can be changed by the Legislature.

19 The KHRCGC will approve applications and set the rules and fines for violations. The rules and fines must be
20 approved by the Kentucky State Legislature before they become legal. The KHRCGC will have the power to
21 revoke licenses for repeated violations of the regulations or for major violations of regulations.

23 Section 4: This bill will go into effect 6 months after the Legislature approves of the rules and fines.
