An act to to end human trafficking at the FIFA World Cup and Olympic Games.

Be it hereby enacted by the General Assembly of the United Nations

Justification Clause: An estimated 27 million people were trafficked in 2012, and due to a lack of global initiative, only 47,000 of these victims were found. Over 40% of all trafficking victims are kidnapped and sold through large scale athletics events such as the Olympics and the World Cup of the Federation Internationale de Football Association (FIFA). To address this travesty, future host nations of the Olympics and the FIFA World Cup will be required to submit proof of their ability to adequately address the increase in trafficking that occurs at these events.

Section I: While nations submit a bid to host the Olympic Games or the FIFA World Cup, potential host nations are also required to submit sufficient evidence that they will plan for and execute specific actions in order to address the increase in human trafficking that is present at these international events. The host nation will submit the report to the United Nations Global Initiative to Fight Trafficking (UNGIFT).

Section II: The human trafficking report must include the following elements:

1. The person who will be appointed as head of the Human Trafficking Task Force (HTTF) and their background and qualifications for the position.
2. A history of human trafficking in the nation.
3. A plan for community education in regards to human trafficking at the competition.
4. Recruitment plan for the creation of the HTTF.
5. The training and curriculum for the HTTF.
6. Overall budget for the execution of the above action steps.

Section III: Host nations are required to create a Human Trafficking Task Force (HTTF). The HTTF must consist of current police officers or volunteers in state law enforcement. They must undergo at least two years of comprehensive training in the signs of human trafficking, current suspects, and the highway system surrounding the event location. This task force must be equal in size to 10% of the total security task force of the event. HTTF members may also serve in secondary security roles at the event, in addition to being on the HTTF.

Section IV: Host nations will be required to execute a community education curriculum. The curriculum must educate the event spectators in identifying human traffickers and victims of human trafficking, and provide information on whom to contact if a spectator believes they have identified an incident of human trafficking.

Section V: UNGIFT will appoint an advisory board to oversee the preparation of host nations to fight human trafficking at the Olympic Games or World Cup. Each board member will have at least ten years of research or work experience with human trafficking, human rights violations, or law enforcement. The advisory board will be responsible for reviewing bid proposals and reporting findings to the International Olympic Committee and FIFA, as well as supporting selected host nations throughout their training and preparation for the actual event.

Section VI: The UNGIFT Advisory Board will review all applications and place each nation into a tier system, which will be public information for the global community. The UNGIFT Advisory board will place the applicant nation into a tier based on their ability to provide adequate personnel and training for the global game to combat human trafficking.

Section VII: UNGIFT will provide funding to nations to support them in their attempt to combat human trafficking during their global event. The amount of funding will vary based on a tiered scaled developed by the UNGIFT advisory board. The criteria of each tier will be rooted in a nation's ability to meet the guidelines set forth in this proposal without the assistance of the UN.

Section VIII: UNGIFT has an annual budget of \$2.5 million to support countries in the education and training of law enforcement to address human trafficking.

Section IX: This proposal will be enacted 90 days after passing. Any bids for the FIFA World Cup or the Olympics submitted in or after 2015 will be required to follow the regulations put forward by this proposal.
