1           An act to require that EBT cards have an identification picture on the card and that another form of  
2           identification must be shown at time of use to insure identification of user.  
3  
4           **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**  
5    Section 1: This bill will require that EBT cards have a picture of identification on them and that another  
6    form of identification such as a drivers license must be shown the ensure the identification of the card user.  
7  
8    Section 2: This bill will prevent people from using and selling EBT cards bought on the Internet.  
9  
10   Section 3: TThis bill will require that stores check for identification of user by asking to see a  
11   drivers license or other form of identification. If a store is caught not checking for  
12   Identification they shall have penalties as follows.  
13   1<sup>st</sup> offense: \$1000 fine and probation  
14   2<sup>nd</sup> offense: \$2500 fine and probation  
15   3<sup>rd</sup> offense: \$5000 fine and probation  
16   If a fourth offense occurs license of distribution can be claimed or other penalties can be put  
17   into act.  
18  
19   Section 4: Penalties for individuals caught are as follows.  
20   1<sup>st</sup> offense: \$250 fine  
21   2<sup>nd</sup> offense: \$500 fine  
22   3<sup>rd</sup> offense: \$1000 fine  
23   If a fourth offense occurs prosecution can be decided in court.

25   Section 5: This bill will be at a minimal cost to the government.
