- 3                   **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

- 5   Section 1: there is currently no law
- 6
- 7   Section 2: With the seemingly high amount of children effected by food allergies, asthma, and diabetes, an
- 8   emergency can happen at any moment of the school day.
- 9   With poverty stricken families not able to go to the eye-doctor or dentist, the school nurse can provide
- 10   eye screenings and general mouth health.

- 12   Section 3:It could cost between 10,000 - 40,000 per school. The KY Department of Health and Family
- 13   Services will be in control of the requirements of this bill.

- 15   Section 4: The law would take effect the 2016-2017 school year.
