- 1                   An act to establish rehabilitation for drug users without bail for 3 months .

- 3                   **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**
- 4
- 5   Section 1: Rehab centers must have strict monitoring with who comes to visit and what items visitors bring
- 6   with them.
- 7
- 8   Section 2: Participants must communicate with an accountability partner (someone either of the law or who
- 9   has graduated successfully from the program) about where they are in the recovery process.
- 10
- 11   Section 3: Funding for centers will come from non-profit organizations for drug users.
- 12
- 13   Section 4: Individuals who are unsuccessful in the rehabilitation program will be returned to the court system
- 14   for a court date to assign jail time.
- 15
- 16   Section 5: This bill will be experimented in the following counties if approved starting January 1, 2015.
- 17   Trimble County, Carroll County, and Jefferson County. If successful will implement for the whole state in
- 18   January 2016
