1 An act to require all prisons to force inmates to pay/work for their meals.

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

5 Section 1: To require all prisons in the Commonwealth of Kentucky to force their inmates to pay or work for
6 their meals.

7

8 Section 2: A prison is a building for the confinement of persons held while awaiting trial, persons sentenced
9 after conviction, etcetera.

10

11 Section 3: This bill is needed because it will lower taxes, and the amount of money the government needs to
12 spend on prisoner's meals.

13

14 Section 4: This bill will be enforced by the Human Rights Commission (HRC)

15

16 Section 5: In an inmate is not capable of working or paying for their meals, the prison will have an account
17 that family and friends can donate money for the inmate so they do not have to work. This will be known as
18 a meal account.

20 Section 6: For every hour of work, the prisoner will receive one dollar and fifty cents (\$1.50).

21

22 Section 7: The work will include picking up trash, cleaning up the prison, and other jobs needed by the
23 community. The tools will not include anything that the inmates could use to rebel or break out in a riot.

25 Section 8: This bill will have no cost.

26

27 Section 9: If a prisoner refuses to work and does not have a meal account set up by family and friends, a bill
28 will accrue that they will have to pay for when they are released from prison.

29

30 Section 10: All laws or parts of laws that are in conflict with this bill are hereby repealed.

31

32 Section 11: This bill will go into effect six (6) months after passage and the signature of the governor of
33 Kentucky.
