1 An act to provide the option of having your blood type on your driver's license.

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

5 Section 1: Hundreds of individuals in Kentucky are injured every year and made unable to communicate
6 essential information to medical staff, such as their blood type. This can have terrible health repercussions
7 by slowing down the time needed to perform sometimes necessary blood transfusions. This bill will provide
8 for the option of having one's blood type information on driver's licenses for individuals in Kentucky.

10 Section 2: This bill will require that local Circuit Court Clerk's offices include blood type information on new
11 Kentucky driver's licenses on an optional basis. The Kentucky Circuit Court will enforce this bill.

13 Section 3: The money needed to fund this modification of licenses will come from a \$2 increase in the cost of
14 a driver's license for individuals wishing to include the blood type information.
15

16 Section 4: If an individual local Circuit Court Clerk's Office is not in compliance with this regulation, that is,
17 they refuse or are unable to include the blood-type information, they will be given a warning and four
18 months to correct the situation. If not in compliance after four months, restaffing of the Circuit Court Clerk's
19 Office will be an option.

21 Section 5: All laws or parts of laws in conflict with this bill are hereby considered null and void.

23 Section 6: This bill will go into effect May 1, 2015.
