 Deeply disturbed that a 2016 audit of the meatpacking industry found that about 6 percent of cattle slaughtered in the Amazon came from illegally cleared ranches,

1. Requests help in developing a plan to offer government subsidies(refunds) when farmers purchase farming equipment to clear land versus burning;
2. Further requests the UN to advise the Brazilian government to enact stricter penalties on those caught burning lands illegally;
3. Seeks money to assemble crews to clear burned land and replant lost trees in order to resolve lost oxygen production and work toward the goal of the Strategic Plan for Forests;
4. Considers introducing a plan to implement a 10% fee to be levied on meat purchased from ranches who operate on illegally cleared land;

Noting with deep concern, industrial pollution in Bulgaria has become an urgent problem that cannot be ignored, by one estimate 85 percent of Bulgaria's river water is polluted with industrial waste and 70 percent of farmland has been damaged by industrial emissions,

Bearing in mind, Bulgaria has many environmental problems due to industrial pollution which they cannot solve on their own, such as raw sewage from factories flowing into the ecosystem which causes sewage to spread throughout the Baltic Region posing a major threat to the environment,

Recognizing Bulgaria has the highest concentration of the two major varieties of particulate matter, which are tiny airborne droplets or gas particles that come from smokestacks, vehicle tailpipes or a variety of other sources, which can lead to health problems from asthma to cancer, furthermore, Bulgaria has the highest number of premature deaths due to air pollution in Europe,

Taking into consideration, the United Nations has previously assisted in reduction of industrial pollution in Bulgaria by placing smokestack filters inside the factories, however this method proved inefficient and expensive with the price tag of 200 million Euros,

1. Calling upon, the UN to invest and install alternative energy sources in major Bulgarian factories to decrease the use of coal and fossil fuels which will expand the use of renewable energy sources,
2. Further requesting upon, the UN to help assist in building facilities which separate reusable, biodegradable, and unusable waste reducing Bulgaria's output of industrial waste,

An Effort Regarding the Violence Issues in German Schools

The General Assembly,


Currently, in German schools, especially elementary schools, students are becoming excessively violent towards their teachers. These innocent teachers are being physically hurt and violated in their everyday workplace. This resolution will help these teachers not to fear for their well-being every day as they go to work. Additionally, this will help the violent students to discover new ways of releasing built-up emotions with coping mechanisms and aid in conflict-resolution.

1. Work to create an organization of trained persons who specialize in effective disciplinary actions for students who have violent tendencies. These trained administrators will first handle the initial issue of the violence these students are portraying. They will explain to and train the teachers on how to handle a student being physical whenever an administrator is not present. Once disciplined, the students will begin the process of learning how to properly handle their emotions without hurting themselves or others. This will be based upon a conflict-resolution process.
2. The conflict-resolution consists of six vital steps that will teach the staff and students of these schools how to work together in a safe environment. They will (1) clarify what the problem/disagreement is, (2) establish a common and reasonable goal for the staff and students to reach with behavioral issues, (3) discuss individually and then together how they will work to meet their goal, (4) set healthy barriers with their goal, (5) agree and voice their opinions on how to best resolve and conflict their disputes, and (6) acknowledge the responsibilities each staff and student must take in order to safely and effectively reach their goal.
3. The conflict-resolution and behavior training organization will charge each school district \$1,495, which is a very minuscule fraction of the budget. We would like to consider the spending of each school and make sure they were not spending excess money on the schools that have no behavioral issues. These representatives will rotate around the schools in their district. This will be resulting in effective training that will profit the organization without hurting the school's budgeting.
4. This will pertain to the students and staff of German elementary schools, specifically the students who have had past records of being physically violent. Once proven successful in German schools, we will work to create an adaptation to aid other countries prone to in-school violence. These countries could include America, Europe, Finland, and Austria.
5. This resolution will be enacted and enforced by the United Nations Third Committee of social, humanitarian, and cultural issues.
6. This resolution will go into effect 5 months after approval. This will give the schools enough time to decide the best way to collaborate with the organization while also handling and working to stop the violent issues before they get any further out of hand. This will also give time to establish the organization.

Noting with deep concern that in 2018 about 360,000 tons of domestic waste, 140,000 tons of Industrial waste, 720,000 tons of agricultural waste, and 8,500 tons of pesticides were dumped into rivers and the coastal waters of Morocco.


Alarmed by the negative health and environment effects this is having on Morocco and the many other countries bordering the Mediterranean, including Spain, France, Italy, Egypt, Libya, Algeria, and in the Western Sahara region.

Calling upon the U.N that the waste management and disposal system be modernized and expanded throughout the state of Morocco. 14 by the Gulf of Fonseca in the western department of Chinandega to receive drug loads and money,

16 Emphasizing this is just one of the numerous examples of corruption with drugs by government officials in
17 Nicaragua and Central America.

- 19 1. Proclaims in order to fix this problem, it is necessary to implement procedures to limit drug trafficking.
20 Such procedures include the placing of two or more guards at any major import/export along the
21 border, thoroughly inspecting any cargo entering or leaving the country, and requiring thorough
22 background checks to anyone wishing to enter or leave the country. The government of Nicaragua has
23 recently supported the expansion of drug education efforts for its youth. In 2009, these efforts
24 reached nearly 21,000 students. Our goal is to expand this program to include all students in the
25 country. We also aim to build more Narconon drug rehab centers. A drug treatment center that will
26 succeed will also offer a component that enables a drug addict to recover his self-esteem and pride,
27 qualities that are normally lost after a slide into addiction. These are the recovery factors around which
28 the Narconon drug rehabilitation program is built. In some forty centers around the world, addicts are
29 learning to live drug-free by completing the Narconon program.

An Effort Regarding Acid Rain Pollution in Norway

The General Assembly,

As it stands, there is acid rain that is negatively affecting the fish, water, and important economic exports of Norway. Our bill would make it mandatory for coal plants and factories to install scrubbers so that the sulfur dioxide is removed from the smokestacks. For the nitrous glasses being released into the atmosphere from farming, we could use minimum tillage requirements so that the emissions are heavily reduced in farmland.

1. It will be the duty of the plants, factories, and farms to follow protocols set by the United Nations Environment Assembly. This will include requirements on the amount of sulfur dioxide that they put out into the atmosphere and other pollutants from waste. Farms will have minimum tillage they will have to follow and requirements for what they put out for fertilizer and pesticides that can cause acid rain. The required amount of pollutants these factories and farms will need to stay under will be determined on a case by case basis with consideration going to how large the factory or farm is and the materials being produced.
2. The United Nations Environment Assembly will enforce these measures with factories and farms. Those deemed as not following the requirements set forth by the Assembly will have a fine assessed each year they do not meet the requirements. This fine will be two percent of their annual profits. Each year that the factory or farm does not meet the requirements the amount will increase by one percent.
3. The United Nations Environment Assembly will provide volunteers from the assembly countries to assist in conferencing with factories and farms in showing them how to reduce their pollutants into the atmosphere and drinking water. These volunteers will conference with these places for a week at a time on an in-person visit and then be available by phone, email, and letter to assist them for a time period of two years.
The assembly will maintain a committee of scientists that will assess whether or not progress is being made to reduce the amount of acid rain affecting Norway and surrounding countries. The assembly reserves the right to increase requirements if deemed necessary by a lack of progress.

The Prevention of Human Trafficking in Saudi Arabia


The General Assembly,

Fully aware that that human trafficking has imprisoned and enslaved approximately 40.3 million people worldwide, Noted with deep concern that Saudi Arabia’s TIP (Trafficking in Persons) survey rank dropped to tier 3, the lowest ranking possible, in 2019, Emphasizing that the legal system in Saudi Arabia has no minimum punishment for those accused/convicted on human trafficking crimes, Deeply disturbed that victims of human trafficking face humiliation, persecution, and sometimes death for crimes committed against them, Recognizing that the United Nations defines human trafficking as the recruitment, transportation, transfer, harboring, or receipt of persons by improper means (such as force, abduction, fraud, or coercion) for an improper purpose including forced labor or sexual exploitation, Observing that in 2018, the United Nations acknowledged that human trafficking is the third largest crime in the world, Recalling the need to strengthen international and regional cooperation, as well as national coordination, for the effective prevention and combating of trafficking in persons, as states in resolution 25/1, Reaffirming that the Universal Declaration of Human Rights , Article 6, states that no one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms, Alarmed by the fact that the United States added Saudi Arabia to the list of worst offenders on human trafficking,

1. Calls upon the UN to form a Committee consisting of at least five Tier 1 countries to advise Saudi Arabia on how to better combat human trafficking;

The General Assembly,

A total of 6,505 cases of child abuse have been received through the Uganda Child Helpline Service over the last year, ranging from physical to sexual and emotional abuse. In the last two years, 1,843 cases of abuse have been reported. In a nation of 42.7 million people, 58% of girls and 59% of boys below the age of 18 are physically abused, while 35% of both boys and girls are abused emotionally.

In 2018, there were 2844 cases of child abuse registered. Of that, 1449 cases were of child neglect, 799 sexual abuse, 406 experienced physical abuse and 25 were murdered.

1. The solution to this problem would be to hold monthly checkups where trained officers come to each house to detect if people are in distress. The officers' responsibility would be to assess the well being of the child, as well as the living arrangement. This would be piloted in an area with a high rate of child abuse (Karamoja). These will be random check ins after signs of child abuse are detected. If concerns arise, the children will be taken to a special facility equipped with an evaluation center as well as special counseling designed for child abuse victims. The amount of time that a child will be in the facility will vary upon age and the abuse experienced. To create the facilities, renovations will be made to a hospital, costing \$660,000. This will be a pilot program that will test if the facilities decrease the child abuse rates. This bill will cost around \$1.1 million USD This bill will go into effect January 1st 2021

Resolution to Protect Ukrainian Journalists and Media Transparency

The General Assembly,


Deeply concerned, that as of October 2019, 201 press freedom violations took place in 23 regions in Ukraine, ranging from threats and intimidation to restriction of journalists' access to information,

Alarmed by, the index of Physical Security of Journalists identified 90 cases of attacks on journalists in Ukraine in the year 2017 alone, additionally, there is a solid body of evidence that media owners put pressure on editors to change editorial policy according to their political agenda,

Having considered, after 2014, multiple major news sources who reported relevant information on political topics, drastically decreased their content and even certain smaller outlets have announced being subjected to political pressure or actual violence,

Recognizing, freedom of speech is essential to a healthy society and a strong democracy, Article 19 of the Universal Declaration of Human Rights (1948), states that the fundamental right of freedom of expression encompasses the freedom to "seek, receive and impart information and ideas through any media and regardless of frontiers",

1. Calls upon, the United Nations, specifically UNESCO (United National Educational, Scientific, and Cultural Organization) to partner with Ukrainian lawmakers to invest in developing enforceable legislation to protect freedom of the press, which is currently guaranteed in the Ukrainian Constitution, as well as the UN,
2. Further requests, the UN to create a task force to investigate violations of the freedom of the press in member countries and to work with legislative bodies to establish laws protecting and allowing media transparency furthering freedom of expression.

Establishing A Plan For The Further Union of Latin American Countries

The General Assembly,

Deeply concerned about the effectiveness of the Organization of American States,
 Alarmed by the current status of most of Latin America,
 Desiring a closer union among Latin American states in terms of both global and internal affairs,
 Having considered the effects of globalization on the various states present in Latin America,

1. Endorses a plan to strengthen Latin American ties through a formal supranational union, known as the Latin American Union (LAU);
2. Encourages the states of Mexico, Guatemala, Belize, El Salvador, Honduras, Nicaragua, Costa Rica, Panama, The Bahamas, Cuba, Jamaica, Haiti, the Dominican Republic, Saint Kitts And Nevis, Antigua And Barbuda, Dominica, Saint Lucia, Saint Vincent And The Grenadines, Barbados, Grenada, Trinidad And Tobago, Colombia, Venezuela, Guyana, Suriname, Ecuador, Peru, Brazil, Bolivia, Chile, Paraguay, Uruguay, and Argentina to join this union as full members, whose duties entail attending meetings, generally being involved with the LAU and its constituent members, and paying membership dues proportioned by the state's economic status;
3. Further Invites the Philippines, United States, Spain, Portugal, the United Kingdom of Great Britain and Northern Ireland, France, and the Netherlands to join as honorary members, whose duties entail holding meetings in their territory to discuss LAU affairs concerning those outside of the LAU;
4. Recommends meetings in Spain, the Philippines, Portugal, and Montevideo concerning the invitation of France, the Netherlands, the United States, and the United Kingdom of Great Britain and Northern Ireland into the LAU as full members;
5. Further Recommends quarterly meetings concerning internal affairs between full member states in Montevideo, Uruguay and annual meetings between all full and honorary members concerning international affairs affecting Latin America;
6. Requests the United Nations' Department Of Political And Peacebuilding Affairs to provide funding in the amount of \$400 million USD to initialize the LAU;
7. Calls Upon the full member states of the LAU to divide the collective facilitation cost of \$100 million USD per year via membership dues, which shall be apportioned by the economic status of each full member state;
8. Designates the states of Mexico, Guatemala, Belize, El Salvador, Honduras, Nicaragua, Costa Rica, Panama, Cuba, Haiti, the Dominican Republic, Colombia, Venezuela, Guyana, Ecuador, Peru, Brazil, Bolivia, Chile, Paraguay, Uruguay, and Argentina to draft a constitution for the Latin American Union prior to holding the aforementioned annual meetings as the Constitutional Committee of the LAU.
9. Takes Note Of the ensuing conflict of representation of different sides of a political crisis, and solves this dilemma by appointing 5 representatives from each state for both the Constitutional Committee and the LAU General Assembly;
10. Designates the location of the LAU headquarters to Montevideo, Uruguay;
11. Resolves to at least acknowledge and partially solve the multiple problems plaguing Latin America with the LAU.

5 Deeply concerned that Zambia is responsible for having one of the highest child marriage rates in the world,
6 observing that one of the causes of child marriage is the selling of children due to a child’s lack of ability to earn
7 money and support their families, disturbed that this is one of the causes of the high number of cases of HPV,
8 HIV and AIDS in Zambia,

9
10 Fully acknowledging that Zambia is responsible for having one of the world’s highest child marriage rates with
11 42% percent of the female population married before the age of 18, which puts the women at risk for sexually
12 transmitted disease, physical health problems, and etc. And also that HIV/AIDS account for about 11.3% of the
13 population, that this increases the risk of adolescent pregnancy, and for domestic violence,

15 Fully Acknowledging that the Zambian government has put in place campaigns in an effort to reduce child
16 marriage, that ultimately had no significant effect on the child marriage rate in Zambia, and also that child
17 marriage is often a result of parents being forced to marry off their daughters for money.
