Implementation of Sewage Systems and Water Treatment Plants in Kabul

The General Assembly,

Deeply concerning death rates in Kabul, Afghanistan have led us to further research the cause of each death in the city. Studies show that annually 10,000 kids under the age of five die from sanitation caused by preventable diseases, including diarrhea, cholera, and dysentery.

Convinced, proper placement of sewage pipelines would greatly reduce the death rate in Kabul. This city is the 64th largest in the world, populating at 4.635 million. It has been agreed upon by the UNAMA (United Nations Assistance Mission in Afghanistan) that every person should be allowed the basic human right of clean water.

Having examined all the pros, this resolution would positively affect neighboring cities and the city of Kabul itself. The sewage pipes and dump would come to an estimated cost of 1.604 million. For a water treatment plant it would cost an estimated \$500,000 to one million per 150,000 gallons of water needed.

Keeping in mind, the UNAMA has set aside an annual fee for the country of Afghanistan. Our resolution would require a two percent tax increase. After eight years, the sanitary plan would be completely paid for so the tax would reduce again. An additional donation would come from the UNICEF foundation.

Recognizing, the use of the new sanitation devices in Kabul, many pros have come up. With the process of cleaning up the human waste, the excretions could be donated to multiple farms across the country, all used as manure/fertilizer for their crops. Additionally, this resolution would drastically change the amount of money being spent on hospital bills and stays.

1. Supports the use of a city dump to all residents.

2. Further resolving, 300 square miles of sewage pipelines in Kabul will be inserted.

Resolution to Increase Educational Awareness on the Prevention of HIV/AIDS

The General Assembly,

Convinced that the nearly 30 year long civil war in Angola, lasting until 2002, the HIV/AIDS epidemic was kept at a relatively low rate. Since the access throughout the country of Angola, and surrounding countries such as Zambia, Botswana, and Zimbabwe have reopened, the prevalence rate of the Human Immunodeficiency Virus (HIV) has increased significantly in the years after.

Alarmed at the low prevalence rate of Angolan citizens educated about the life altering dangers of HIV and how it is commonly spread is not part of the knowledge of the general population,

Noting with deep concern, that HIV/AIDS has affected close to 80 million lives globally,

Taking note of the Secretary General's report on the implementation of the Declaration of Commitment on HIV/AIDS (2001) and the Political Declaration on HIV/AIDS (2006) (A/65/797),

Recognizing the efforts by the Joint United Nations Program on HIV/AIDS (UNAIDS) to coordinate the global, regional, national and local response to HIV and AIDS and the pivotal role of the Global Fund to Fight AIDS, Tuberculosis, and Malaria in mobilizing and providing international assistance, including resources, to respond to HIV and AIDS,

In order to achieve the goal of education, awareness, and prevention of HIV/AIDS,

1. Calls upon the United Nations to further encourage the incorporation of HIV prevention, treatment, care, and support, including voluntary and confidential counseling and testing, and the need to ensure the continuation of such prevention, treatment, care and support of Angolan citizens;

2. Seeks funding to promote educational programming in both urban and rural areas (especially those that are very remote). Health professionals are greatly needed to treat and educate citizens throughout the country.

The General Assembly,

Deeply troubled by the fact that activists reported that lesbian, gay, bisexual, transgender, and intersex (LGBTI) people face discrimination, harassment, and violence in Armenia. The government has not addressed hate speech or discrimination against LGBTI people.

Incredibly upset that LGBTI men in Armenia are trapped under article 116 of The Armenian Penal Code, which states that men in Armenia aren't allowed to have relationships with people of the same sex.

Disappointed with the fact that over 90% of the population of straight people in Armenia are hostile to LGBTI people and want limits on their rights enforced by the government.

Saddened by the fact that as of 2017, it is illegal for same-sex couples to adopt children, no matter what the case of the couple or the child.

Disheartened by the fact that hurtful protests and fist-fights were immediately posed when the GLAG (Gay Lesbian Armenian Group) was created. It then had to be shut down for the safety of the participants.

1. Requests that the UN reaffirms in a public announcement that every human being is born free and equal, and that everyone is entitled to all the rights and freedoms in the Universal Declaration of Human Rights, without exception of any person, no matter race, color, sex, religion, political or other opinion, national or social origin, property, birth or other status;

 Calls upon the UN to appoint an Independent Expert on protection against violence and discrimination based on sexual orientation and gender identity to help LGBTI people find ways of dealing with discrimination and violence;

3. Asks the United Nations to raise awareness of violence and discrimination against persons on the basis of their sexual orientation or gender identity, and to identify and address the root causes of violence and discrimination;

4. Calls upon the government of Armenia to work in cooperation with other tolerant countries in order to implement extra measures that contribute to the protection of all persons against violence and discrimination based on sexual orientation and gender identity;

5. Pleads that Armenia's government, in cooperation with the UN, creates facilities to house children and teens who have been disowned by their parents because of their sexuality.

Catastrophic Impact of Leaking Nuclear Reactors in Belgium

Need for Educational Support in Bhutan

The General Assembly,

Emphasizing the importance for the need of professional teachers to develop quality curriculum.

Recognizing that according to the Global Partnership for Education (5.6.3) in Bhutan's plan to "build linkages with external agencies working in areas of special education needs for exchange programs, technical support and research."

Bearing in mind, article 26 of the United Nations Human Rights, "everyone has the right to education..."

Acknowledging a report from UNESCO that states, "In Bhutan, teaching is considered a "last resort," it is assumed that those who cannot do anything else end up in a classroom. For this reason many students avoid teaching as a career, causing the education system to remain stagnant." (Samantha Davis, Borgen).

Taking note that there are still 1 in 10 children not receiving education in Bhutan due to lack of resources and teachers.

Reaffirming that with education, all areas of life improve (health and greater job opportunity) while enhancing Bhutan's national plan for Gross National Happiness, in the education domain.

 Request that Bhutan allows outside allied agencies and representative teachers into the country to help remediate our curriculum and provide model teachers to collaborate with existing teachers.

2. Bhutan will allow extended VISAs and living accommodations for outside consultants, providing a small stipend for extra expenses while living in the country.

3. Partner with volunteer teaching agencies such as Peace Corps to help absorb cost from Bhutan's budget, and in return allow a richer culture experience for educated volunteers to experience Bhutan's Gross National Happiness.

4. Place a ten year cap on this inaugural program, allowing to revisit a need in the future.

Gender Equality in Bulgaria

 The General Assembly,

 Noting with deep concern that gender inequality and women's rights is a legitimate issue in Bulgaria, resulting in a greater unemployment rate, unfair wages, violence against women and girls, early and forced marriage, health rights, education, discriminatory employment opportunities, unpaid care work, limited control in property, and unequal participation in private and public decision making,

Recalling that Bulgaria was said to strongly support women's empowerment and gender equality in United Nations General Assembly resolution 64/292 and Human Rights Council Resolution 15/9 in 2007, we have confirmed that gender equality along with the empowerment of women is a stand-alone goal,

Having examined the UN bill, "Statement on Gender Equality and Women's Empowerment and Water and Sanitation for a Sustainable World By Croatia and Bulgaria" at 11th Session of OWG SDGs we have reaffirmed that gender inequality is a violation of the Charter of the United Nations,

Conscious that a vote could be taken to allow the United Nations to build a secure facility by members of the Bulgarian Parliament and donations by member countries of the United Nations can contribute to creating a protected sanctuary for women who have been in early and forced marriages, violent acts, or abusive relationships,

Bearing in mind that "it is widely recognized that securing gender equality is among basic principles in the respect for human rights and the key imperative for overall economic and political progress, no country has yet achieved full equality for women and girls and women are still underrepresented and sometimes even marginalized in most countries,",

1. Calls upon the UN Entity for Gender Equality and Women's Empowerment to construct a secure facility in Bulgaria, using donations from member nations of the UN, for women who have been forced into the violent acts mentioned above.

2. Requests the UN Entity for Gender Equality and Women's Empowerment to report to the General Assembly on the results and the amount donated by member nations (2.5 million dollars) to be used for building materials, supplies, and other needed equipment for said facility.

An Act to Provide Disease Prevention Education in the DRC

The General Assembly,

According to the Humanitarian Health Action publication in the World Health Organization, 3 million people have died in the DRC in the last 5 years due to Preventable and Treatable diseases. Additionally, an estimated 400 children die every day with nearly half of the deaths from Malaria, and other endemic diseases. Hundreds of people die in the DRC due to diarrheal diseases, such as cholera. These can be prevented with interventions currently available. This is a qualifying reason for action. We plan to provide education and the necessary resources available to solve this major issue.

To combat this issue, we will start by providing education on preventative measures such as hand
washing and good sanitation. In addition, we will introduce water purifying tools and products like the
Pee-Poo© which is a biodegradable toilet. We also seek funding for disinfectants, insect sprays,
mosquito nets and food covers. We will work with volunteers from UNICEF® to teach our citizens how
to use these products.

2. Regarding finances, funding will come from our valuable natural resources estimated at 21 trillion United States dollars. Additionally, we plan to partner resources from several other countries at an estimated cost of 1 to 5 million dollars.

3. Should the resolution pass, quality of life will improve for millions of Congolese, thereby extending the life expectancy. Without these, the living condition for the citizens could worsen as each second, hour, day and week passes by. This proposal will then be modelled to other impoverished countries which are in dire need.

4. We plan for this to go in effect 100 days after passage.

Recalling that the use of illegal narcotics poses a great threat to humanity of all races and ethnicities around the world, as declared in resolutions 44/16, 34/173, 72/197, and 52/92,

Recognizing that 20% of the 1,306,788 people who have inhabited Estonia have partaken in the use of illegal narcotics, as 18% of the narcotic user population are below the age of 25, while approximately 230 users overdose per year,

Emphasizing the abundance of amphetamines among illegal narcotic users, without having a reliable treatment plan for this drug, only having needle and syringe programs open to the public along with take-home naloxone programs,

Noting with deep concern the fact that treatment in the public sector is primarily funded by the Ministry of Social Affairs. While almost half of the budget is set aside for opioid substitution treatment, the remaining funds are divided among other small treatment plans,

Bearing in mind the previous statement, Estonian citizens as well as citizens of other nations do not have available resources for the treatment of amphetamines, and have no way to get reliable treatments for their illegal narcotic addiction,

Conscious of steps taken by Germany and Denmark in order to maximize treatment plans include needle and syringe programs, take-home naloxone programs, drug consumption rooms, and heroin-assisted treatment,

Determined to provide a variety of treatments including amphetamine treatments available to Estonians, New Zealanders, Russians, and Mexicans as well as other countries all across the world, funded by the Ministry of Social Affairs (of all countries), by dividing funds evenly among the various treatment plans,

1. Urges other countries to when designing drug intervention programs confirm that they have treatments for a variety of drugs including needle and syringe programs, Take-home naloxone programmes, drug consumption rooms, and heroin-assisted treatment;
