Virtual Code of Conduct

It is important that our participants and guests feel welcomed and safe in our programs. This code of conduct embodies the spirit of the Y, and is intended to help everyone feel comfortable and thrive. As a YMCA participant or guest, we ask you to agree to follow this code of conduct which is rooted in our core values.

These requirements also serve as an extension and supplement to any codes of conduct students and participants must abide by for in-person programming.

1. Appropriate Video Call Etiquette:
 - When registering/signing-in for any video call or meeting, please use your **First & Last Name** (not a random username), as well as your **School** in parentheses (for KUNA, please include **COUNTRY instead of School**).
Example: Curious George (Monkey Acad.). This helps us to ensure the privacy of our meetings.
 - Please find a quiet area and call in at the scheduled meeting time so that you can be fully present in the virtual experience. We ask that all participants have their video function on their device if possible so we can see and hear you.
 - Please do your best to keep background noise or distractions to a minimum. Mute yourself when you are not speaking.
 - Please do not take your phone or computer to the bathroom.
 - Photos and videos of others without the expressed consent is prohibited.
2. Cell phones, music players/speakers, or other wireless communications should not be used during meetings or formal programming time.
3. Appropriate attire: Appropriate attire must be worn at all times. Clothing with vulgar language, obscene gestures, racial slurs, or anything that contributes to a hostile environment or would be considered inappropriate in a YMCA program is not allowed. Appropriate tops and bottoms should be worn.
4. Appropriate language: Vulgar language, including swearing, name-calling or shouting/yelling at others is prohibited. When communicating in the chat box, please do not send links or information that is not aligned with our YMCA core values.
5. Appropriate Interactions: Participants shall demonstrate respectful, responsible, caring, and honest conduct before, during, and after all KY YMCA virtual interactions. This includes but is not limited to: social media, physical and verbal interactions, electronic communication. Above all else, other people's needs/requests must be respected. *Bullying of any kind will not be tolerated. This includes but is not limited to physical, verbal, mental, cyberbullying.*
6. All delegates share the responsibility for their actions when violations committed by students or adults are witnessed. Those present who do not act to remedy and report the violation shall be considered participants. There are no "innocent bystanders."
7. Creating a welcoming environment: Respect others' cultures and personal way of being. We strive to create a safe emotional and physical space. We encourage participants to honor diversity in all dimensions and respect opinions or perspectives. The Kentucky YMCA stands up against all forms of bullying, discrimination and racism.
8. Appropriate conduct: Any other conduct of an inappropriate, threatening or offensive nature will be investigated/evaluated by YMCA staff. Participants that do not abide by this agreement may be prohibited from participating in future virtual events or in-person activities.
9. Physical intimacy between participants is inappropriate at all times during Kentucky YMCA programs. This includes, but is not limited to: romantic interactions, unwanted or inappropriate physical contact, unwanted comments/conversation, etc.

10. Alcohol, Tobacco and Drugs: The use of alcohol, tobacco, and drugs (including e-cigs/ tobacco-like products) is not permitted in or outside of ALL virtual calls. Participants that show, obtain, see in the background, make references to or use during the virtual calls will be removed from meeting and removed from future virtual and in-person events. Law enforcement may be involved if necessary.

If a participant or guest feels uncomfortable in confronting someone directly about offensive behavior or other issues that are in violation of this code of conduct, we ask that you please report the behavior or issue to Kentucky YMCA staff.

To create and maintain a space that embodies our core values, the Y is serious about being clear regarding activities that are not allowed. If you violate this code of conduct, consequences can include termination of program privileges, being removed from all virtual programming, and involving appropriate legal authority. The YMCA reserves the right to make situational decisions based on our policies, mission, and values.

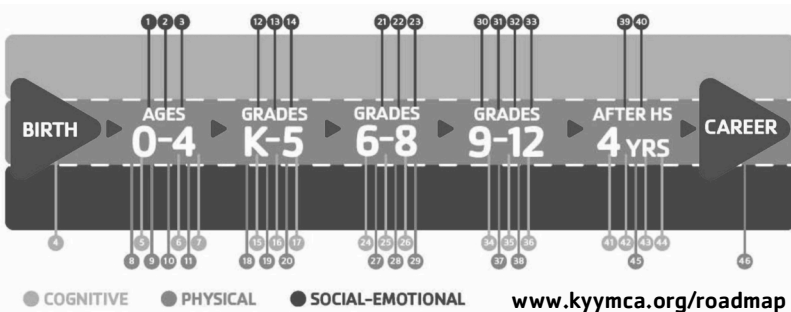

ADJOURN	A MOTION to close a meeting.
BILL	A proposed law presented for approval by the Assembly.
BILL TITLE	The subject of the BILL.
CAUCUS	A meeting of a group or party, generally to make a decision on behalf of their group.
CHAIR	The Chairperson or Presiding Officer.
DIVISION (OF THE ASSEMBLY)	A MOTION to force a standing vote; generally invoked when a voice vote is unclear.
DOCKET	A list of BILLS to be presented.
MAJORITY VOTE	More than half of the votes cast.
MOTION	To introduce a proposal for consideration by the CHAIR.
PARLIAMENTARY INQUIRY	To request advice on procedure from the CHAIR. SENATORS or REPRESENTATIVES may make this point at any time another delegate is not speaking.
REPRESENTATIVE	A member of the House.
ROLL CALL	Calling the names of all members to determine their presence.
SECOND	A personal approval of a motion, generally making it subject to debate.
SENATOR	A member of the Senate.
STATE OF THE COMMONWEALTH ADDRESS	Made by the Governor and containing a review of the general condition of the state and his/her recommendations to the Assembly.
TABLE	A MOTION to defer action on a BILL.
TWO-THIRDS MAJORITY	The majority vote is at least double the minority vote.
VETO	Privilege of the Governor to reject passed legislation.
YIELD	To relinquish time to another Representative or Senator

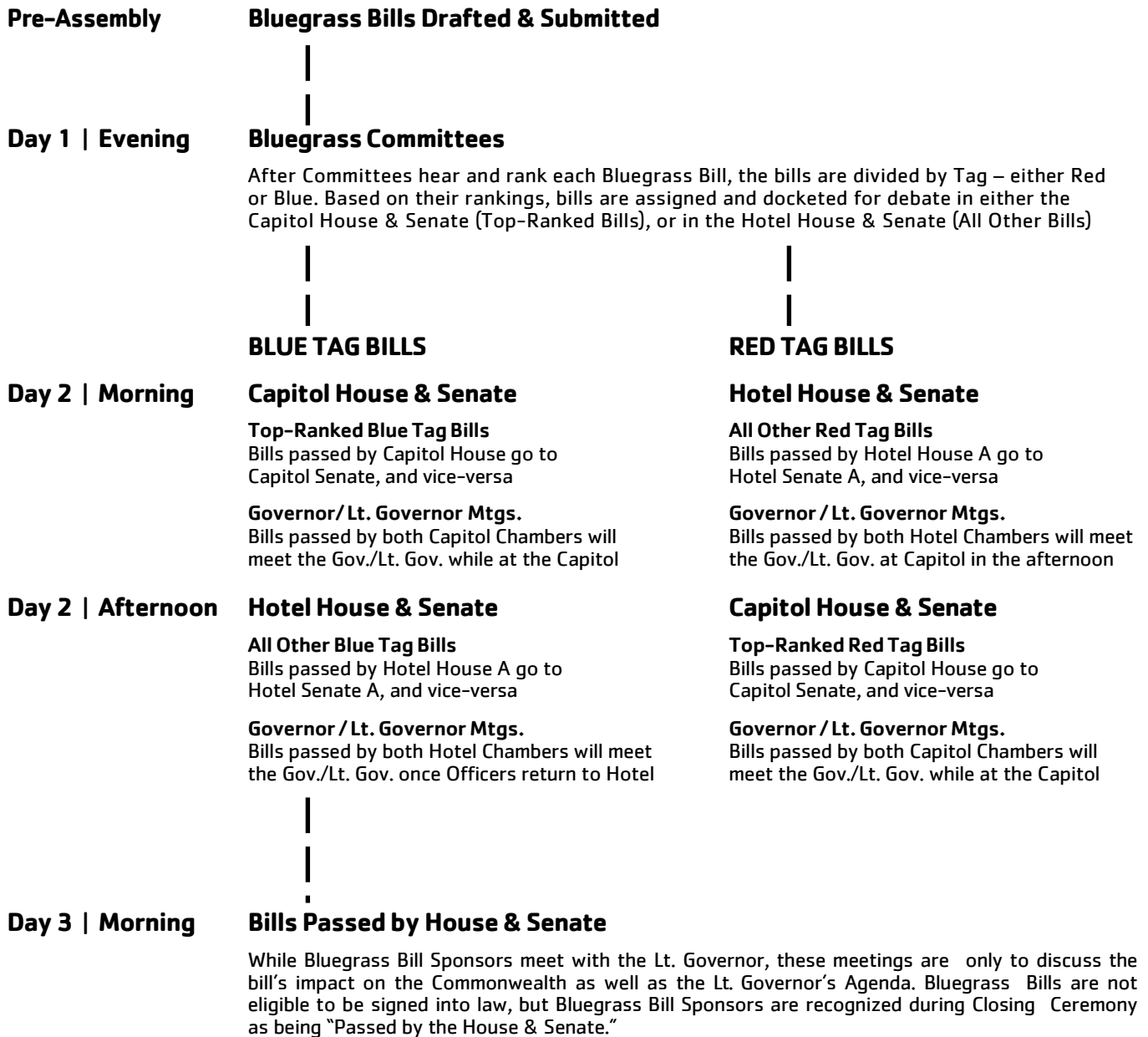

SECOND AMENDMENT RIGHTS FOR NONVIOLENT FELONS

Be it enacted by the Youth Assembly of the Commonwealth of Kentucky

Section 1: A NEW SECTION OF KRS CHAPTER 527.040 IS CREATED TO READ AS FOLLOWS: 527.040 Possession of firearm by nonviolent convicted felon -- Exceptions -- Applicability to youthful offenders.

Section 2: KRS 527.040 is amended to read as follows: 527.040 Possession of firearm by nonviolent convicted felon -- Exceptions -- Applicability to youthful offenders.

(1) A person is guilty of possession of a firearm by a convicted felon when he possesses, manufactures, or transports a firearm when he has been convicted of a felony, as defined by the laws of the jurisdiction in which he was convicted, in any state or federal court and has not:

- (a) Been granted a full pardon by the Governor or by the President of the United States; or
- (b) Been granted relief by the United States Secretary of the Treasury pursuant to the Federal Gun Control Act of 1968, as amended.


(2)

- (a) Possession of a firearm by a convicted felon is a Class D felony unless the firearm possessed is a handgun in which case it is a Class C felony.
- (b) If a felon is convicted of a criminal offense other than possession of a firearm by a convicted felon, and he or she possessed a firearm in commission of that offense, then the felon shall be penalized for violating this section one (1) class more severely if it is a second or subsequent violation of this section.

(3) The provisions of this section shall apply to any youthful offender convicted of a felony offense under the laws of this Commonwealth. The exceptions contained in KRS 527.100 prohibiting possession of a handgun by a minor shall not apply to this section.

(4) The provisions of this section with respect to handguns, shall apply only to persons convicted after January 1, 1975, and with respect to other firearms, to persons convicted after July 15, 1994.

(5) Violent felony offenders are not allowed to carry a firearm as classified in KRS 493.3401.

An Act Relating To Declawing Cats


Be it enacted by the Youth Assembly of the Commonwealth of Kentucky

Section 1: This law will prohibit all forms of declawing cats, including declawing, tendonectomy, and onychectomy. Declawing is an inhumane act, and therefore shall be abolished in all forms.

Section 2: Declawing, tendonectomy, and onychectomy are all procedures that put the cat in pain. It is also the cause of many behavioral problems, including biting and not using the litter box. It also results in many physical problems, including chronic pain, arthritis, lameness, nerve/tissue damage, gangrene, abscesses, paw pad atrophy, bone regrowth, osteomyelitis, and back pain. In no ways is this procedure beneficial to the cat, unless it is necessary for its health.

Section 3: This bill would be enforced by the Kentucky Humane Society. If one is to violate this law the owner of the cat will be fined \$500 and the person who performs the procedure or extracting of the claws will be fined double the money they got from the procedure.

Section 4: The law will be put to effect immediately and will include all people in Kentucky. This bill will be disregarded if a licensed veterinarian determines a cat needs to be declawed for health issues. This is only to be allowed in extreme cases, however, where it is absolutely necessary for the cat to be declawed, and there is no other option.

5 Section 1: A NEW SECTION OF KRS CHAPTER 138 IS CREATED TO READ AS FOLLOWS: People need to
6 reduce the use of nicotine inside vaping products.

8 Section 2: A vape pod is an electronic device where users can breathe in vapor through the mouthpiece. They
9 come in different flavors and scents to attract people of all ages. It can be very harmful to your body. It
10 makes you dizzy. Nicotine can also cause depression. Nicotine stimulates the release of the chemical
11 dopamine in the brain. Dopamine is involved in triggering positive feelings. It is often found to be low in
12 people with depression, who may then use cigarettes as a way of temporarily increasing their dopamine
13 supply. Nicotine is one of the products inside of the vape pods that gets people addicted to it. The amount
14 of nicotine should be limited and reduced to help people with a possible addiction to this overcome that
15 challenge.

17 Section 3: This bill will go into effect on December 31, 2021.

Section 1: In Kentucky, feminine products are a “luxury item” meaning that under the law, feminine products are not reasonably necessary. These luxury items are outrageously expensive and not everyone can get their hands on them. We want to take this act away. We believe that anyone with a uterus should get these products for a cheaper price, as they did not choose to have their menstrual cycle.

Section 2: We want to create a law to have cheaper feminine products in stores and public restrooms. Almost every woman in this world has a menstrual cycle, feminine products, such as pads and tampons, are a necessity. Not even just women, transgender men still have to struggle with not affording pads and tampons because most of them can still have a uterus. In an average box, there are about 36 tampons and we use 4 of them every day for about a week. This comes around every month and each box of tampons costs about \$7.00. This would round to about \$1,773.33 for a lifetime and \$150-\$300 every year for just tampons, not including pads, which we also need. Some restrooms have products but they are about 50 cents for a single tampon/pad and very few restrooms have them. Many people cannot afford this and we all need to be sanitary and safe during our menstrual cycles.

Section 3: Scotland just recently was the first nation to make feminine products free. The law supplies access to free products in schools, universities and public places. This has helped so many people have a safe, affordable, and sanitary menstrual cycle. Although its hard for us to make them free, making them cheaper is a huge possibility.

Section 4: How will this bill be paid for? We will spread the news through social media such as youtube, tik tok, and Instagram to get planned parenthood’s attention. There will be links to fundraisers, and if we need to raise taxes by 5% to those not in poverty. Cops also get funded 3.8 million dollars a year. A lot of these funds go towards unreasonable military-grade weapons. Section 1: Creating more programs to help children stuck in neglectful homes. Kentucky leads first in child neglect in the US with a record number of 10, 000 cases. It is difficult to prevent all cases of child abuse, but you can still aid children in need with charity and volunteer work. Collecting supplies and donations through school programs. These donations will be provided to any child in need. There will be more availability for staff so students can report any situations at home. Along with clothing and comfort there will be more accessible food drives for children in low income families. These programs will be non-profit and will be free for anyone to donate or volunteer.

Section 2: Provide more thorough welfare checks to identify more harmful environments. In the Kentucky government system, 0.6% of government funding is used on welfare and social services. Taking funds from overly funded programs will increase the amount of money spent on social services, allowing them to perform better during neglect or endangered welfare situations. Sections that will be taken from will be transportation and police funding specifically in areas with unneeded funding. This will bring the funding up for public assistance about 0.3%. There will be several more case workers fulfilling welfare checks and will have to be checked to make sure they are completing checks and identifying situations correctly.

Section 3: Provide more school psychologists and counselors. People at school to be able support children and help them in tough situations. These teachers and staff workers will help children realize all of the opportunities for help they have. For every 350 kids of 7-12 grade there is one counselor but only a small number of kids (1 out of 450 kids) actually use the counselors frequently. There will be more freedom given to staff members so they can easily confront and aid children who are suspected to be in danger. This will come in the form of rule changes such as ensuring confidence in teacher reports and shortening the decision-making process to retain the importance of the case.

Section 4: Create more programs to inform children about what it's really like for a child in an abusive situation. More lessons in the teaching curriculum to further improve the child's understanding of child abuse and neglect. Schools will be able to give small quizzes and reports of student understandings. This will show how effective these lessons and programs are and will allow further improvements from there. There will be repeating sessions from certified staff members to teach the effects of these situations. This will also allow student concerns for peers to be more open and well-thought out. It will also teach staff how to better listen in on the student reports and corrections.

An Act Relating To Funding Minority Voters

Section 1: To support minority voters, a 2% tax will be placed upon all citizens of Kentucky. This tax will take 2% of every citizen’s yearly income. This 2% tax will take roots on January 1, 2022, so that we’re ready for the 2024 presidential election and any other elections that follow. This will provide poll sites for minority voters and everyone’s voice will be heard. With everyone’s voice getting heard, this will much more so enforce and add to America’s democracy subject and help with equaling the playing field for everyone in the state of Kentucky by providing everyone the ability to effectively vote and have their voice and opinion heard.

Section 2: It is proposed that Section 147 of the Constitution of Kentucky be amended to read as follows: Citizens of voting age will be sent and are requested to fill out a mail-in ballot and go through the process of voting and submitting said ballots to be verified and counted. Also, the minimum number of voting hours that workers are allowed to take leave to vote is 5. Bus fares and taxi costs will be lowered down to \$0 across the state of Kentucky on said voting day (no matter the year or voting purpose) in order to adequately transport voters to poll sites. Any statute contrary to this Act shall be amended or repealed. To add to the already existing voting laws in Kentucky we will be allowing more access to voting areas, especially in areas where minority voters reside. We also plan to make it easier for citizens to vote by allowing mail-in ballots to be mailed every year to citizens without an excuse being required.

Section 3: In order to figure out where these new polling sites are needed, a survey will be sent to every citizen aged 18 or older in the state of Kentucky. This survey will be sent by mail and by email once every two years. There will also be people who will go door to door and hand out the surveys. It will be asked that every citizen fills out and returns this survey. The survey will include the following questions: Do you usually vote? Yes or no If you answered no to the following question, why? Where do you live? Where is the nearest polling site located? Basic information (Age, name, etc.) The answers to these questions will provide information that is needed to determine where new polling sites are needed. New polling sites will be set up in schools, churches or other buildings in areas that do not have any nearby polling sites.

Section 4: The tax that is placed upon Kentuckians will account for the following: Salaries for ballot assisters The surveys sent out and received Payment for those who count the received surveys Renting poll sites and building set ups for voting cubicles, areas, etc. Paying government bus companies and taxi corporations to make up for any lost salary for Election Day

Section 5: This Act takes effect on January 1st, 2022 in time for that year’s state election as well as future presidential elections. The tax we collect from this time forward will pay for the poll sites that will be set up according to the survey results that are to be sent out immediately.

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

5 Section 1: According to the U.S Energy Administration (EIA), “The United States used about 392 million
6 gallons of finished motor gasoline per day in 2018. Most consumers use gasoline in cars, light trucks, and
7 motorcycles, but they also use it in small aircraft, boats and other watercraft, and landscaping and
8 construction equipment. (“Gasoline Explained”) There are millions of greenhouse gasses going into the air
9 due to these public transits. If our country is going to have any environmental improvement, this needs to
10 change.

11
12 Section 2: Public transit emits a surplus amount of greenhouse gases/carbon dioxide into the atmosphere
13 (this severely damages the ozone layer). Electric versions of these do not emit any gases, and improve the
14 ozone layer drastically. Public transit is more environmentally friendly for communities, and if it is carbon
15 neutral, it will truly aid the world and state of Kentucky.

17 Section 3: A NEW SECTION OF KRS CHAPTER 224 IS CREATED TO READ AS FOLLOWS.

19 (1) All public transit in Kentucky shall become carbon neutral by the year 2024.

21 (2) A tax of 2% income will be imposed on those that use gas powered public transit by the year
22 2023 (and a 5% income tax for those that own the transit).This bill will enforce the use of electric

25 Section 4: The higher tax from the government will aid the cost of the carbon neutral transportation

Section 1: This Bill mandates that all women, having given birth to a child and being one of fifteen or more employees, are hereby granted twelve weeks of paid maternity leave.

Section 2: This bill pertains to all female residents of Kentucky with employers that have more than fifteen total employees.

Section 3: It is hereby mandatory that in the first seven weeks of maternity leave, the employee shall be paid 80% salary. During the remaining five weeks of the leave the employer shall grant his/her employee half salary.

Section 4: It is only mandatory for the employer to grant paid maternity leave if he/she has fifteen or more total employees in his/her business. If the employer has under fifteen employees in his/her business, then he/she is not required to grant a paid twelve weeks of maternity leave. The employer is entitled to the choice of whether leave shall be granted.

An Act Relating to Using Body Cams While on the Clock

Be it enacted by the Youth Assembly of the Commonwealth of Kentucky

Section 1: We are creating this law due to recent safety concerns in our state. After the recent shooting of Breonna Taylor the public has become more and more wary of the police. This act is to regain trust in the police system. It will help prove when in court who is guilty, if any offending officer has nothing to hide then this transition to institute body cameras will be no hassle at all


Section 2: In section 95.015 rights and duties of police officers in the kentucky state laws, we propose a new law to be added. We propose an enactment to force all members of the police, while on duty, to wear a body camera while partaking in law enforcement of any kind. This body camera must be on and filming at all times. Under no circumstances may it be turned off while at any crime scene.

Section 3: Any violation of this law will result in a minimum of \$200 dollars and a maximum of 10 years and a 10,000 dollar fine. Other punishments may include community service hours or dismissal. An example of a minimum fine would be a minor bar fight where no major harm was inflicted upon any individual and the police officer simply did not have their camera recording. An example of a maximum fine is when you are found directly responsible for the death of at least one person and you did not have your camera recording.

Section 4: This bill will not require extra funding.

Section 5: This bill will go into effect a week after this bill is passed

Section 6: All police officers are required to wear a body camera while on the clock. Any statute contrary to this act shall be reprimanded or repealed.

4 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

6 Section 1: This bill mandates that the state will provide the foster care system with qualified employees to
7 appoint responsible and qualified individuals for Fostering children. Some of the qualifications include: every
8 individual(s) being mentally and economically stable, to be able to provide a safe environment for the
9 child/children, and not have a past record.

10

11 Section 2: This bill needs to be abided by all occupants of the state of Kentucky.

12

13 Section 3: Each individual living in the household that the child will be staying in will be required to have a
14 background check. This background check will include: talking to their pre- existing children, their other
15 family members, neighbors, and of course checking their health, record, credit, and mental state. Not only will
16 there be background checks for the families, but also for the social workers! If we have more certified and
17 qualified workers, it will make the foster care system 10x easier.

18


19 Section 4: The money funding Foster care systems in Kentucky is provided by the Federal government. There
20 are two types of Foster care systems, which are both being funded by two different organizations.
21 "Privatized Foster Care is funded by a 3rd party private agency" Privatized Foster Care systems risk not
22 having that money to pay from that 3rd party agency. We would need to make sure to have that money to
23 pay for the Foster care system. This will include taking a portion of tax from regular taxes along with taking
24 a small grant of money from diapers and other nesisties that children need in order to give more money for
25 foster care systems.

27 Section 5: Once a week each foster child should be checked in on *unless already adopted* (by their CPS
28 worker). Connection with family, feeling safe, and background checks will be taken into consideration along
29 with any other information proven helpful. If a child is struggling in their new home, actions will be made to
30 ensure that the child will be in a safe, fitting family. (ie. re-training parents and anything else agreed on)

32 Section 6: This bill will go into effect the first of January, 2021 and proceed to be carried out until voted out
33 by the federal government in the state of Kentucky.

An Act to Require Electric Charging Stations

Be it enacted by the Youth Assembly of the Commonwealth of Kentucky


Section 1: This bill will require the state to place a charging station, within its state line, for every 1,000 cars owned by the citizens. The stations will be required to have at least 2 chargers.

Section 2: Each station will cost approximately 1,000 dollars and the pay will be divided between the government, whoever owns the station, and non-profit organizations. The cost of charging your car will be up to the owner of the station. Each station is required to pay taxes but the price will be up to the government.

Section 3: If the state does not follow the regulations, then they must have to pay a fine up to 5,000 dollars per offense. If a charging station staff does not follow these regulations, the consequences are as followed: The offender will have to, pay a fine of 2,000 dollars The offender will have to, pay a fine of 3,000 dollars and the offender will have to be kept under surveillance The person who has completed all three offenses must be removed from the staff of the station Each employee will have three strikes after completion of the three strikes they will be removed from the staff of the station. The offences will carry over even if the offender doesn't do anything wrong for a few years/months.

Section 4: Once the state has reached another 1,000 cars the government will have 10 months to place another charging station. After the deadline of 10 months has passed, the government will have to pay 1000 dollars a month before the charging station is built.

Section 5: The bill will take effect on January 1, 2022.

Governor's Bill Signing Announcement

After meeting with the Sponsors of all Commonwealth Bills that passed the House & Senate, as well as consulting with the Cabinet and the Budget Committee, the Governor will announce (after Fun Time on second night) which Commonwealth Bills are being signed into law.

If your bill passed the House and Senate but was not announced, then has been vetoed by the Governor (Note: there are NO vetoes at MS KYA – all Commonwealth Bills passed by the House and Senate are signed into law). A full list of vetoes will be posted by the Y-Desk. Bill Sponsors wishing to challenge a veto can sign-up for the Veto Override Session at the Y-Desk.




Day 3 | Morning

Veto Override Session | HS KYA Only

At HS KYA, prior to the start of Closing Ceremony, any Bill Sponsors who wish to challenge the Governor's veto will be given the opportunity to do so during the Veto Override Session.

Bills on the Override Session docket required a 2/3-majority vote of the Assembly to be heard. If the vote is successful, the Governor and Bill Sponsors each get 1 min. to speak. Bill Sponsors can yield part of their time to Lobbyists, and the Governor can yield to a Cabinet Member or the Attorney General. A final simple majority vote is required to override the veto and enact the bill into law.

1 An Act Relating To Food Deserts In The Commonwealth Of Kentucky.

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

4
5 Section 1: A food desert is defined as a geographic area where access to affordable, healthy food options,
6 such as fruits and vegetables, is limited or nonexistent, because grocery stores are not within close
7 proximity. They are most commonly located in low-income areas, as well as rural areas. This is due to the
8 fact that this specific population has such a long distance to travel to the nearest store.


9
10 Section 2: This law will give a one time 15 percent tax credit to certified stores that open in areas
11 considered as food deserts. Stores would be able to apply to receive tax credits to open in a food desert.
12 This would ensure that those of any class or zip code have access to nutritionally adequate foods.

13
14 Section 3: Food deserts are most commonly located in low-income areas, as well as rural areas. This is due
15 to the fact that this specific population has such a long distance to travel to the nearest store. With limited
16 options within a mile radius of most homes many turn to unhealthy foods that are close at hand. This little
17 access to nutritious foods is also related to higher rates of illnesses and shorter life spans, along with
18 obesity, which is one of the largest rising health issues. Other contributing factors to this problem are
19 inactive lifestyles and diets.

21 Section 4: This law will be enacted by January 1, 2021

1 An Act To allow households to have chickens in the city limits.
2
3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**
4
5 Section 1: This bill will allow homeowners to have no more than 10 chickens per home and no roosters
6 allowed. Apartment and home renters will not be allowed to raise their own chickens. Large amounts of
7 manure must be disposed of to where the smell is not noticeable. Composting is the preferred method of
8 disposal but bagging and disposing with the garbage, just like pet waste, is acceptable. Chickens on private
9 property must be housed out of sight of the public view. Adequate chicken coops are required and must be
10 enclosed at all times.
11
12 Section 2: Currently several cities in Kentucky allow chickens to be kept as pets with varied restrictions.
13 Because each city has different ordinances, this bill proposes one law to be adopted state wide.
14
15 Section 3: This bill will help Kentuckians who live where there is little access to fresh foods, a term called a
16 food desert. In recent years there has been a big push in addressing food deserts by growing vegetable
17 gardens. However many cities restrict owning chickens in city limits but this bill will override that restriction
18 and allow residents to raise chickens which provides a daily protein source in eggs.
19
20 Section 4: Many states already allow chickens in city limits for example California, Colorado, Florida, Iowa,
21 and Illinois. In some states only certain cities are allowed to have chickens in city limits, like Nevada which
22 has only two cities which are allowed to have chickens in city limits.
23
24 Section 5: If this bill is passed any home that gets reports of rooster crows in their chicken pens will be
25 investigated. If there is a rooster the first offense will be \$150 and for every other offense will be another
26 \$50.
27
28 Section 6: This bill will not require any funding from the State of Kentucky. Chicken owners may have
29 additional expenses in order to meet the requirements of the new law. This bill will go into effect January 1,
30 2021.

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

4

5 Section 1: Children with poor hygiene become social outcasts, which affects their self-esteem, grades, and

6 their desire to even come to school. In 2012 West Plains Elementary School started handing out hygiene

7 bags and is seeing a 5% attendance increase.

8

9 Section 2: This bill would require all schools to hand out hygiene bags every 9 weeks to less fortunate kids.

10 Different bags would be handed out to different ages and genders. For children 5th grade and up the bag

11 would include deodorant, shampoo, conditioner, a toothbrush, toothpaste, bar soap, a hairbrush, and

12 feminine products if needed.

13

14 Section 3: This law will be enforced by The Kentucky Department of Education.

15

16 Section 4: This bill will cost 80-120 dollars per student per year depending on age and gender. The funding


17 will come from donations and government funding.

18

19 Section 5: First offense is \$100, each 9 weeks this bill is not implemented is an additional \$75.

20

21 Section 6: This bill will go into effect the start of the 2022-2023 school year.

1 An act to require all pregnant women 12 weeks of paid maternity leave.

2

3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

4

5 Section 1: Each pregnant woman in Kentucky currently gets 6 weeks of paid maternity leave, and we believe

6 it should be more.

7

8 Section 2: New mothers need more time with their newborns. We propose that each woman get 12 weeks

9 maternity leave with pay.

10

11 Section 3: According to lawlabor.com, women are protected by the Pregnancy Discrimination law and the

12 Family Medical Leave law. Basically, these laws state that a woman cannot get fired or deducted pay simply

13 because she is pregnant. Our law would be that women get 12 weeks of paid maternity leave so that she has

14 more time to bond with the newborn without financial stress.

15

16 Section 4: This law would be effective January 1st, 2021.

17

18 Section 5: It would be around \$4,200 for 12 weeks per woman, depending on their weekly salary. (this is

19 based on a \$50,000 yearly income, but rates may vary). The punishment for not obeying this law would be

20 the employer would have to pay the woman what they owe them, and then pay the Commonwealth of

21 Kentucky the same amount.

22

23 Section 6: Other states that have implemented this law are California, Rhode Island, and New Jersey. This

An Act Relating To Kentucky's Unemployed Workers

Be it enacted by the Youth Assembly of the Commonwealth of Kentucky

Section 1: A NEW SECTION OF KRS CHAPTER 341 IS CREATED TO READ AS FOLLOWS:

(1)This bill will create an act that will provide jobs for the unemployed in Kentucky by providing public job applications at local government offices.

(2)These forms will be available to all citizens, not just those who have recently filed for unemployment.


Section 2: Any statue contrary to this Act shall be amended or repealed.

Section 3: Jobs available in these offices will be completely made of public jobs, providing workers with the minimum wage. Forms will also include a list of candidates for these public jobs. This will help citizens gather more information about their potential career paths.


Section 4: This bill only requires money for the cost of paper and ink for printing. This money shall come from the government building itself and shall not require any additional funding.

Section 5: Failure to print these forms after 3 months will result in a \$500 fine to the government building.

Section 6: This bill will go into effect on January 1, 2021.

Section 1: The current law in Kentucky states that A number of federal and state laws and regulations involve health care, such as Medicare, and Medicaid, the privacy rights of patients, the legality of physician-assisted suicide, the right to choose your own end-of-life care, and more.

Section 2: There is no additional cost to enforce this bill. This bill will be implemented by the Louisville Metro public health department, which is already existing, therefore it will come at no cost, with an exception to the already existing salary medical staff. The salary is paid by taxes and can range from \$30,000 to \$60,000 each year per medical assistant, depending on their jobs

Section 3: In Kentucky, there must be a law to remove the chargemaster, and have fair and set prices for medical equipment (tools, exams, etc). There should also be a law to tax high income people, and put more into providing effective and reasonable healthcare, and hospital bills and healthcare should be free for people below average income (\$48,000).

Section 4: This bill will help citizens of the United States of America. In many ways this includes preventing citizens from going bankrupt. As stated by the Washington post over 500,000 people go bankrupt every year because they cannot pay their outrageous medical bills. If this bill turns out to be law we estimate that it will help most of the low-income residents

An Act relating to the reformation of Kentucky's schools system

Be it enacted by the Youth Assembly of the Commonwealth of Kentucky

Section 1. Whereas, schools will be required to provide life skill classes beginning in the 7th grade until graduation, and Whereas, it is a crucial responsibility of the Commonwealth to promote an inclusive environment for members of the LGBTQ+ community, and Whereas, the Commonwealth should require schools to promote the wellbeing of students and screen students' mental health, and Whereas, schools would be required to offer shortened school days and eliminate excessive homework, and Whereas, schools will be taking large steps towards abandoning standardised testing.

Section 2. KRS 158.1415 is amended to read as follows, after (3) insert "(4) Knowledge of the LGBTQ+ community and what it means to be a part of it. (5) Age appropriate anatomy of the human genital area on both sexes, Male and Female"

Section 3. A NEW SECTION OF KRS 158 IS CREATED TO READ AS FOLLOWS:

- (1) The Commonwealth of Kentucky hereby swears that it will not pass a law against the positive promotion of homosexuality and or the LGBTQ+ community in the education system
- (2) The Commonwealth of Kentucky also swears not to pass a law in favor of the negative promotion of homosexuality and or the LGBTQ+ community in the education system.
- (3) All public schools are to be accepting and not against LGBTQ+ students and staff, and are not to ignore signs of bullying or harassment because of a student's sexuality or gender.

Section 4. A NEW SECTION OF KRS 158 IS CREATED TO READ AS FOLLOWS:

- (1) School will begin to move toward abandoning the sole use of standardised testing on the basis that it negatively affects students' mental health.
- (2) Schools will be required to use at least one alternative to standardized testing including, but not limited to, sampling, stealth or game-based tests, wellness assessments, portfolio assessments, and are encouraged to use as many as possible in measuring a students intelligence and accomplishments.

Section 5. A NEW SECTION OF KRS 158 IS CREATED TO READ AS FOLLOWS: (1) Public school hours are to start no earlier than 8:30 in the morning. This is to allow for 7 and a half hours of school time while still getting children home by 5:30 and relieving the stress of waking up early.

Section 6. A NEW SECTION OF KRS 158 IS CREATED TO READ AS FOLLOWS:

- (1) Schools are not allowed to give out mandatory work for the child to complete at home seeing as it can greatly negatively affect a child's mental health.
- (2) Homework will be allowed to be presented to the willing student for extra help or credit, but will not be mandatory.
- (3) If a child does not complete their work by the end of the class the student will still be expected to follow their schools rules on completing that assignment, however Teachers are required to provide plentiful time to work on the assignment throughout the day.


Section 7. A NEW SECTION OF KRS 158 IS TO BE READ AS FOLLOWS:

- (1) Schools will be required to conduct mental health screenings on students towards the middle of their 6th, 8th, and 11th grade year.
- (2) Schools are required to screen for Depression, ADHD, and Anxiety Disorder.
- (3) Schools are encouraged to screen for identity disorders, Schizophrenia, eating disorder, sleep disorders, ADD, OCD, and PTSD.

Section 8. It is appropriated to the KDE from the AWARE grant of \$9 Million dollars for the purposes of Section 6. of this Act.

Section 9. Any statute contrary to this act will be amended or repealed

Section 10. This Act takes effect on July 1, 2021.

1 An Act Relating To Improving Awareness for Kentucky Youth about Risks of Social Media Related Human
2 Trafficking

3
4 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

5
6 Section 1. Since 2007 there have been a total of 373 reported cases and 869 reported victims of human
7 trafficking in the state of Kentucky. This does not include all of the cases and victims that go unreported
8 each year. This bill will increase awareness of human trafficking that occurs through social media by educating
9 the youth of Kentucky. This legislation will allow Kentucky State Police, local law enforcement per county,
10 and youth advocates to connect with and educate students at their local school about the signs and risks of
11 human trafficking. In addition, each agency previously listed will utilize their social media platforms to
12 present public service announcements about the dangers of human trafficking on social media.

13
14 Section 2. This will be funded by applying for a federal law enforcement "block" grant that is not required to
15 be repaid by the state of Kentucky. The funds will be issued to an appointed organization which includes, but
16 is not limited to, the members of the agencies in section one.

17
18 Section 3. This organization will be required to go to all middle schools and high schools every two years and
19 host an assembly that teaches the signs and ways to help put a stop to domestic human trafficking.

20
21 Section 4. Community service will be a main part of providing support for this organization. In order to
22 enforce the bill, organization members will need to recruit individuals for volunteer work, provide service
23 hours for high school students, and host design contests for promotional materials.

24
25 Section 5. This bill will go into effect by July 1, 2021.
