1 An Act relating to requiring juvenile sex offenders 16 years or older to be tried as adults in court.

2
3 **Be it enacted by the Youth Assembly of the Commonwealth of Kentucky**

5 Section 1: This bill will apply to rape and sodomy convictions of the first and second degree.

6
7 Section 2: Changes to the current sexual abuse statutes for first and second degree, for rape and
8 sodomy are seen in section 3 and 4. The only changes to the current Kentucky statues 510.040
9 through 510.100 are in the ages. This would mean that minimum age for a person found guilty of first
10 or second degree rape/sodomy would change from over 18, to 16 and up in all the areas listed.

12 Section 3: Rape/Sodomy in the first degree: (a) Sexual intercourse/deviate sexual acts with someone by
13 forcible compulsion when the aggressor is 16 years or older, or (b) sexual intercourse/deviate sexual
14 acts with someone who isn't capable of consenting due to being physically helpless, or less than twelve
15 (12) years old when the aggressor is 16 years or older.

17 Section 4: Rape/Sodomy in the second degree: (a) Being eighteen (18) years old or more, he/she
18 engages in sexual intercourse/deviate sexual acts with another person less than fourteen (14) years
19 old. (b) Being sixteen (16) years old or more he/she engages in sexual intercourse/deviate with another
20 person who is mentally incapacitated.

22 Section 5: To implement this bill, no cost is required.

23
24 Section 6: This bill will be enacted January 1, 2018.
