Who Can Pick Up Your Child

Only adults 16 years of age and older listed on a student's Release Form will be able to take students from the program site. In case of a last-minute change or addition, please contact the program director at 502-599-5973. Email authorization is accepted from a parent/guardian's email address that we already have on record. The Kentucky YMCA will not release students to anyone, under any circumstance, other than those stated above. Anyone picking up students must carry a photo ID.
