LETTER FROM OUR CEO

Dear Friend,

During the 2018-2019 programming year, we at the KY YMCA challenged ourselves in new ways. We are the nation’s largest Youth and Government program in terms of reach and programming, but **there is a difference between ‘all are welcome’ and ‘we built this with you in mind.’** So, we sat down and asked ourselves: Who are we serving? Are we meeting their needs? Who are we not yet serving, and why? Are we providing a safe and welcoming space for all of our participants, volunteers, and staff to grow, be challenged, and thrive?

I am happy to share we have many reasons to celebrate!

- We are serving over 10,500 unique teens from 111 of Kentucky’s 120 counties, and our participant makeup mirrors that of our Commonwealth’s.
- Our program reach continues to grow at the individual level at a rate of 3-5%, and our average scholarship award increase means we are supporting more high-needs youth.
- We are recognized and consulted as a national leader in Youth and Government programming, and frequently engaged by Y-USA as they develop a national framework for teen programming.
- We were again recognized by Y-USA as a DIG Innovation Y, for our ongoing commitment to diversity, inclusion, and the global Y community
- Our fund development efforts led to 106 new donors, 10 sponsors, 9 Community Roadmap Partners, \$244,286.96 annual fund total, and the successful passage of the Kentucky Youth Assembly (KYA) as an income tax check-off option.

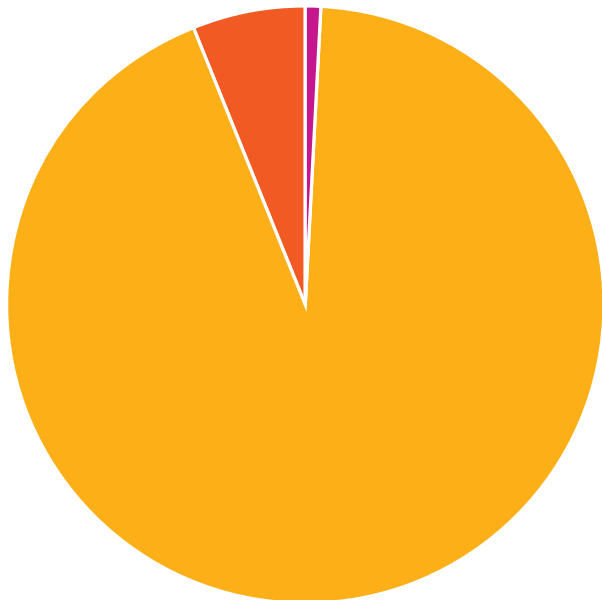
We know there are challenges and shortcomings to face. We are not yet reaching all 120 counties, and we are actively serving only 3% of Kentucky teens. Although our demographic makeup does mirror that of Kentucky overall, we are underserving some groups and communities. Our engagement model is limiting our capability to significantly broaden our reach, and we continue to find ways we can better uplift our youth and volunteers. We are fired up about this new programming year, and energized to tackle these opportunities head on so we can more fully become a Y built with all Kentucky youth in mind. The groundwork we have laid this year will evolve into purposeful recruitment, marketing, fundraising, community partnership development and volunteer engagement efforts; and we are already seeing positive responses to our new initiatives.

Looking back on this year I am in awe of everything we have undertaken and accomplished, and humbled by the community of supporters who help to make this work possible. I am confident that together we can continue to build on our powerful legacy of scaffolding young change makers who will make our communities better for all of us. Thank you for sharing this journey with us, and for making it possible for the Kentucky YMCA Youth Association to dream boldly, act courageously, and celebrate the endless potential of our youth. Thank you for being a change maker in your own right.

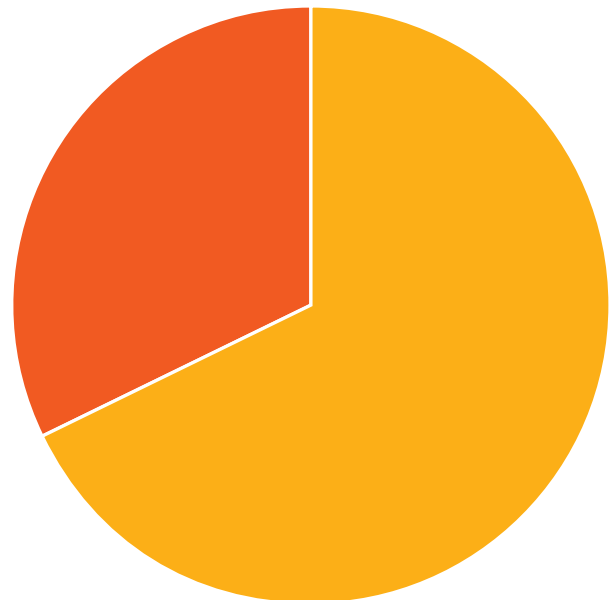
